### Contract

This application properly executed by exhibitor, shall upon acceptance by Pow Wow Committee constitute a valid and binding contract.

### Assignment of Space

Booth spaces will be pre-assigned. Please check with the Pow Wow chairperson upon your arrival. Assignment of booths are final.

### Types of Exhibits

Exhibits shall be limited to authentic American Indian art and crafts. Interpretations of this restrictions shall be the prerogative of the committee.

### Booth space rental rules

The exhibitor will defend, indemnify, and save harmless the Northern Cherokee Nation from any liability whatsoever, and account of any such damage, or injury, whether or not caused by negligence or a breach of an obligation by exhibitor or its employees, or representative.

Exhibitor assumes all responsibility for compliance with all pertinent ordinances, regulations and codes of duly authorized Local, State, and Federal governing bodies, concerning fire, safety, and health.

### Agreement
